To All Landscape Contractors:

The **2021** landscaping season is now in effect. The Kensington Police Department would like to remind all landscapers that a permit is needed to work in the Village of Kensington. Permits may be obtained at the Village Hall located at 2 Nassau Drive between the hours of **9:00am-3:00pm** Monday through Friday. If you should have any questions or concerns, feel free to call the Village Hall at 516-482-4409 ext. 100.

The fee for **EACH** truck permit is a **non-refundable \$50.00 cash or check.** **There is no charge for trailers. Credit cards are not accepted. A VALID COPY OF A DRIVERS LICENSE MUST BE SUBMITTED WITH THIS APPLICATION.** **Failure to obtain the proper permit will result in a summons being issued and a fine rendered.**

Please be advised that the Police Department will begin to issue summonses for all violations of these regulations beginning on **April 15<sup>th</sup>**. **All landscapers must have a valid permit displayed in the front window or dashboard of every truck, van, or other vehicle used in this village.**

As a reminder, the following regulations will be enforced in Kensington:

- No work before 8:00 am and no work after 6:00 pm Monday through Friday.
- No work before 10:00 am and no work after 6:00 pm on Saturdays.
- No work permitted on Sundays or legal Holidays.
- **No gas powered leaf blowers between June 1<sup>st</sup> and September 30<sup>th</sup> or on weekends at any time during the year.**

**NOTE: It is now ILLEGAL for any trucks to enter or exit the Village of Kensington via the main entrance gate at Beverly Road and Middle Neck Road. You must use East Shore Road or any of the side entrances.**
