

Letter for Residents to Send to State Representatives

Dear _____:

As a Village of Kensington resident, I am writing in opposition to the housing compact that is included in the current state budget. While I of course support creating more affordable housing in the state, this is a nuanced issue which simply cannot be forced upon every municipality within ½ mile of a train station, as my village is.

We moved to the suburbs because we wanted less density and a better quality of life. No two villages are alike. Our mayor and trustees know our community better than any government bureaucrat and we elect them to make decisions that are best for our village. Zoning matters are best left to local governments, and this housing compact would overrule our local zoning.

Additionally, the Great Neck peninsula has limited resources with respect to water supply, sewer capacity and school enrollment. Adding a mandated 3% increase in housing density for all municipalities to adhere to is not realistic or even achievable without significant burdens.

As our state representative, I strongly urge you to do everything you can to remove the housing compact proposal from the budget and work with our village officials to create a practical approach that meets the individual needs of our village.
