

# Monthly Police Report

## DECEMBER 2022

### Auto Accidents:

### Aided Cases:

12/01- A resident of Beverly Road was assisted after falling in the bathroom. No injuries were reported and aided refused further medical attention or transport.

### Vacant Homes:

The number of homes reported vacant during the month was 10. All were found to be secure.

### Miscellaneous:

- Police were requested to respond to a Beverly Road home to assist highway department with a dangerous tree removal. Situation was corrected.
- Police were called to an Arleigh Road home to assist with a broken pipe. Water main was located and shut off until plumber could respond to repair.
- Police assisted a resident of Arleigh Road with a medicine issue. Situation was corrected at scene. No medical attention requested.
- Police assisted an elderly motorist with directions after being flagged down. Situation corrected.
- While on patrol police observed a vehicle in the pool/park area. Paperwork was checked and motorist sent on their way with warning.
- While on patrol police observed a tree blocking the roadway at Arleigh Road and Park Road. Area was blocked off and secured until highway department arrived. Situation corrected and road was reopened.
- Roadways were monitored during inclement weather and high winds and information was forwarded to highway department for correction.
- Police were requested to document and notify resident of property maintenance issues observed. Letters were delivered to inform resident of any violations.
- The Kensington Police Department participated in a CPR/AED refresher course as required for NYS certification.
- Temporary No Parking signs were deployed throughout the village in order to alleviate possible traffic /parking conditions.
- Police were called to the rear of an Arleigh Road home for low hanging wires. Upon arrival it was determined to be cable wiring and highway department was on scene and will take corrective action.
- Police were notified of a loose dog on Nassau Drive. The dog was located and owner notified to respond. Situation was corrected.
- While on patrol, police observed a solicitor knocking on a Nassau Drive door. Identification was requested as to proper id and permits. Solicitor had no permit and voluntarily left location with a warning.
- A local report was filed by PD after a light pole was knocked down on Beverly Lane. A check of the area for surveillance footage proved negative results.
- Police were called to Beverly Road and West Drive for an odor of gas. Upon arrival and a check of the area, police and highway department were unable to locate any odor.
- Police responded to a North Drive residence to assist a resident that fell on West Drive. An aided case and local report were filed and village hall notified.
- Police responded to a suspicious vehicle on Arleigh Road. Vehicle was gone upon arrival and a search of the area was negative.
- Light outages/issues were reported throughout the month and submitted to the village hall for repair.
