

Monthly Police Report

March 2025

Auto Accidents:

03/07- A two vehicle collision occurred at the intersection of Arleigh Road and East Shore Road. Both vehicles towed from scene and one driver stated neck pain but refused medical assistance or transport from scene.

03/18- A report of a two-car accident was reported to occur on 3/17. A legally parked vehicle was struck by a driver's education vehicle while operated by a student driver. Student driver left scene at direction of supervising passenger. Driving school notified of incident and summons issued for leaving the scene.

Aided Cases:

03/04- A resident of Nassau Drive was assisted after a fall in the home. Aided refused any further medical attention or transport.

Burglaries:

Cases:

Fires:
