Auto Accidents:

Aided Cases:

10/03- A resident of Arleigh Road was transported to North Shore Hospital after suffering symptoms of the flu.

Vacant Homes:

The number of homes reported vacant during the month was 15. All were found to be secure.

Miscellaneous:

- Police observed a suspicious vehicle with occupants in front of a Beverly Road construction site. Driver was interviewed and ID obtained. All information was verified and driver released from scene.
- Police responded to a report of a suspicious vehicle on Nassau Drive. Upon arrival police located vehicle and spoke with driver. Information verified and driver left scene.
- A lost wallet was dropped off at police station. Police were able to ascertain ownership and returned wallet to owner.
- A large party on Bridal Path was reportedly in violation of the village noise ordinance. Upon arrival police spoke with the homeowners and the music was shut down and guests asked to disperse. Police remained on scene until situation was corrected.
- Police assisted an elderly man after he became confused as to where he parked his vehicle. Police located his vehicle and drove the owner back to location.
- Police were requested to a North Drive home after the resident arrived home to an open front door. The interior was checked and found to be ok. The door may have not been properly closed and high winds may have pushed door open.
- Police responded to a large tree branch blocking the roadway at Beverly Road and Clifford Drive. Highway department notified and responded to cut up and remove branch from roadway.
- Police were called to a Beverly Road home after a home health aide having difficulty with the patient. Upon arrival police spoke with elderly patient and situation was corrected.
