Auto Accidents:

The number of homes reported vacant during the month was 19. All were found to be secure.

Miscellaneous:

- A report of tampering with a USPS mail box was reported at the corner of Beverly Road and Gilchrest Road. Upon arrival it was determined that a sticky substance was on the internal rollers affecting mail insertion. Mailbox was covered and taped off and postal inspectors notified.
- A local report was taken for a missing/stolen license plate on Nassau Drive. Report was filed for DMV purposes.
- A disabled motorist was assisted at the intersection of Beverly Road and West Drive. Vehicle was pushed to the side of the roadway and motorist called roadside assistance for a tow.
